1 Approval of agenda

The agenda was approved.

2 Review of project plan for ebIX[®] distributed flexibility project phase II

Postponed until next meeting.

3 BRS Measure for Billing

Kees has been working on the BRS Measure for Billing and he informs that it is becoming a serious recast. But that also leads to some additional questions, preferably to be answered before he continues.

Kees has rewritten the processes along the lines of our latest meeting:

- The "validate-part" has been taken out and Kees has tried to combine this with the present chapter in the Introduction to ebIX[®] BRSs and models;
- We must define the "validate-part" part in "validate and exchange from Validator to Metered Data Administrator" (role not yet available) and rework this to "validated measurements for Metering Points", where the Validator validates without awareness of the using next process. This is knowledge (rules) at the Metered Data Administrator;
- We can probably use the present validated data for billing grid cost as the start for the data exchange from the Validator;
- We must also check the requirements for the other processes to make sure this set becomes complete.

Kees has kept the exchange process from the Metered Data Administrator as it is now. Then it is for the billing clear for both split responsibility (grid and supplier) and combined (supplier/customer centric).

Conclusions:

- The Validator (Metered Data Responsible) sends measure data to the Metered Data Administrator, who is responsible for distribution to other Entitled Parties;
- We try to model one document structure that the Validator (Metered Data Responsible) can use for all kind of information sent to the Metered Data Administrator.

4 Re-review of BRS for Manage Accounting Points after comments from ETC

The BRS was changed after a discussion in ETC. The main proposed changes were:

- a) The UseCase "Create Accounting Point" was renamed to "Include new Accounting Point in Metering Point administration";
- b) Originally the documents used for Connect, Disconnect and Decommission of APs were merged to one set of documents (change of Accounting Point connection status).

Conclusions:

- We go back to "Create Accounting Point" instead of "Include new Accounting Point in Metering Point administration", as the Metring Point administration is the one and only, and we rename the top use case: manage AP's in the MP administration;
- We keep the "Change of Accounting Point connection status" as common documents for Connect, Disconnect and Decommission of APs;
- Ove will update the BRS and sent it to EBG for 14 days of commenting before publishing (we see the change as an update of comments received during circulation for comments that not need resubmission to ebIX® Forum).

5 Review of BRS for Alignment of Metering Configuration Characteristics

The BRS was reviewed and updated up to chapter "1.1.4 Business Domain View: Change metering configuration characteristics".
