The BRS for Alignment of characteristics of a Customer at an AP has been sent to ebIX® Forum for approval. However, during the ETC meeting the week before, it was noted that in the UseCase diagrams we list the Consented Party as a «Business Partner», but since this not is a role, we miss codes for the Consented Parties in “Appendix A Header and Context information for the class diagrams”.

Possible options:

- a) We keep it this way;
- b) We add a comment that Consented Parties must be specified nationally;
- c) We add a list of possible Consented Party roles in the UseCase descriptions (or in the UseCase diagrams).
