### 3 Short review of minor changes to BRS for alignment of AP characteristics

Gerrit, Kees and Ove had done extra reviews of the BRS for alignment of AP characteristics, hence these updates were gone through. The updated BRS will be sent on circulation for comments to EBG/RtR for one week before re-published at <a href="https://www.ebix.org">www.ebix.org</a>.

Among others, the following were agreed during the review:

- Making a BRS for alignment of Exchange Points characteristics was added as a new item C) under Appendix A (EBG project and survey list) / A.1;
- Ove will add the following statement

We will always list all «Business Partners» in the lower level UseCase diagram and in the related UseCase description.

in the "Memo - ebIX (EBG) update principles for BRSs" and send it to ETC for comments;

- It was also agreed to use «include», instead of «extend» in the UseCase for Change Accounting Point characteristics, and similar in the Use case for Change Metering Configuration characteristics. However, since making a rule for this is difficult, we will not add this as a rule in the "Memo ebIX (EBG) update principles for BRSs";
- In due time update the Business Processes in all BRSs, remove the states and mention the exchanged entity.
