1 Approval of agenda

2 Approval of minutes from previous meeting

The minutes of the previous GoToMeeting, June 8th, and the previous face-to-face meeting, February 4th and 5th, were approved without comments.

3 Status and resolving possible matters of EBG administrative tasks

3.1 Status for review of BRSs by GoToMeetings, see Appendix A

For Structure BRSs, the BRS for Alignment of Metering Configuration Characteristics is being reviewed, while there are two more out of 17 BRSs left for review. We aim to finalise these before the coming summer.

For Measure BRSs, the BRS for Measure for Labeling is being reviewed. One out of 9 BRSs has been finalised (Measure for Collected Data) and one BRS (Measure for Billing) is awaiting a last circulation for comments to EBG/RtR before sent to ebIX[®] Forum for final approval.

Because of the pressure on Kees we decided to continue on new BRSs after summer.

3.2 Review of EBG project and survey list, Appendix B

EBG project and survey list in Appendix B was reviewed and updated.

Actions:

- Ove will prepare a discussion document that among others includes a list of BRSs where we use or could add give- and/or check consent processes, such as in BRS for Energy Flexibility Services. There should be a "no" somewhere from the check consent and what to do after a "no" (in exceptions?), see Appendix B/B.1/item F).
- Sylvia will find the status for Gateway, Gateway Operator and Gateway Administrator in Germany, see Appendix B/B.1/item G).

3.3 How to speed up the review of Measure BRSs?

Is it an option that Ove maintains (temporarily) the Word version of the Measure BRSs and Kees maintains the MD model to speed up the process of RtR-recasting the Measure BRSs?

Gerrit informed that there was a telephone conference the week before, where also Manuel Sanchez (from EU commission) and DSO representatives participated. However, without getting any new members to the ebIX[®] Flex project phase II.

Based upon this meeting the decision how and when to start will be brought to the ebIX[®] Forum, maybe at an extra meeting before next normal ebIX[®] Forum meeting.

5.2 Common ebIX[®] and ENTSO-E project for "Area master data"

Kees are preparing an update of the project plan to be discussed at the September CIM EG meeting.

5.3 ebIX[®] project for "Master data for energy industry parties, such as BRPs and BSs - Master Data Parties"

The project is put on hold for the time being. The project plan can be downloaded from the ebIX[®] File Manager.

Kees mentioned that IEC/WG14 is working on a recast of CIM elements related to addresses, parties, etc.

A status for IEC/WG14 work on recasts of CIM elements related to addresses, parties, etc. will be added to the EBG meeting September 28th.

As a result, MNEG has drafted a MR to ebIX[®], based on an old MR template originating from ETC. NMEG ask EBG to discuss the MR before eventually forwarding it to ETC, who may create MRs to IEC.

9 CIMbion – An Engine To Facilitate Integrated Energy Markets (from DNV GL)

We are currently consulting with customers (mainly SOs) to learn more about their needs and how CIMbion can support their operation.

14 AOB

14.1 Request from Bosnia and Herzegovina

Bosnia and Herzegovina have informed that they have decided to use ebIX[®] as reference model for defining messages for data exchange for all business processes relevant for the retail electricity market.

Further, they have asked for help with implementing country-specific xml schemas.

14.2 Status for EG1

In phase 1 of EG1 it was suggested finding a common reference model for data exchange in the European downstream energy market.

Kees informed that ebIX[®] is not and will not be registered as a European body for the energy market at the EU Commission, hence ebIX[®] is not allowed to participate in phase II of EG1. Now, policy makers of organisations such as EDSO, GEODE, CEDEC and Eurelectric are making business requirements for data exchange in the European downstream energy market.

Current definition:	A domain under balance responsibility where Energy Supplier change can take place and for which commercial business processes are defined.

Proposal for definition (EBG October 2019):	The administrative entity where responsibilities (roles) are linked to parties and energy exchange is established.

	This is a type of Metering Point.
ETC review February 2020:	ETC was not in favour of the new definition (for instance the text "where responsibilities (roles) are linked" applies also for Exchange MPs) – suggest a new round in EBG.
Proposal for definition (Gerrit June 8 th , 2020):	The administrative entity where responsibilities (roles) in the liberalised energy market are linked to parties and energy exchange is established and under balance responsibility.
