### 5 CIMbion – An Engine to Facilitate Integrated Energy Markets (from DNV GL)

Part of our innovation strategy and commitment to support our client to safeguard the environment, we have been granted a fund to develop a pre-testing tool that help TSOs/DSOs in Europe integrate BRPs, BSPs, FSPs into the different platforms used to balance the market and manage the grid based on standardized information exchange - CIM (IEC 62325).

This will help especially RES and demand side providers to provide services to the market and contribute to the security of supply leading to formation of a liberalised and harmonised European energy market.

We are ready to engage with ENTSO-e, TSOs/ESOs/DSOs, BSPs and BRPs (inc. RES, Aggregators and DSR) to develop a tool tailored to their need, supporting ENTSO-e to realise the EU vision.

We are currently consulting with customers (mainly SOs) to learn more about their needs and how CIMbion can support their operation.

I would really appreciate if we can share the brochure with ebIX®. They could be one of our key stakeholders and it is important to consult with them or maybe they might be interested in joining the design sprint process we are following to develop the tool ..."
