1 Approval of agenda

The agenda was approved with the following additions:

2 Approval of minutes from previous meeting

The minutes from previous meeting were approved without comments.

During this item, the rule agreed at the previous meeting: "A text describing a "Dependency" shall be added to all optional attributes," was amended. Instead we add a text in the introduction to all BRSs:

Since the ebIX[®] model is open for national customisation, some attributes are added as optional for usage for regional/national customisation. If used, these attributes must be specified nationally.

The item will be removed from the "Memo - ebIX (EBG) update principles for BRSs", since this will be a standard introduction text for all BRSs.

Action:

• Ove will add the text above to all BRSs, however not with a high priority.

3 Review BRS for Measure validated measured data

Comments in the BRS was reviewed and updated from the beginning. At the next meeting we will start on chapter 3.2 (continuous metered AP) before we continue with chapter 3.1 (profiled metered AP).

New actions:

• Kees and Stefan (and all) will check if we need a "Register read date" in the Register read class for continuous metered APs;

- Ove will ask Jan (SE) if Sweden needs the Registration date/time at Time series level in the validated measured data;
- Ove will clean up the BRS Measure for validated data.

Continued actions:

- All will verify some gas related questions:
 - Is the Aggregated Reception Station still used (and what else)?
 - In Sweden the Calorific Value Area is used. Aggregated Reception Station, Temperature Zone etc. are not used – And, gas specific quality codes are not used.
