1 Approval of agenda

The agenda was approved without comments.

2 Approval of minutes from previous meeting

The minutes from previous meeting were approved after having added Kees as present at the meeting.

3 Review BRS for Measure validated measured data

There was a longer discussion related to a proposal for definition of Direction (action from previous meeting for Ove). The discussions ended in a new suggestion for how to handle the direction for Exchange Points:

- The attribute Neighbouring Metering Grid Area was removed from the Validated measured data for Exchange Points.
- It was added a footnote to the Direction attribute:

The Exchange Point is connected to two Metering Grid Areas, hence the Metered Data Responsible sends two time series, one to each Metering Grid Area. The two time series will have different Directions.

• New definition for the Direction attribute for Accounting Point or Exchange Point:

A code specifying the direction of the energy flow.

A flow from the Accounting Point or Exchange Point into the Metering Grid Area is defined as production and a flow from the Metering Grid Area to the Accounting Point or Exchange Point is defined as consumption.

• And a slightly different definition for Installations:

A code specifying the direction of the energy flow.

A flow from the Installation into the Metering Grid Area is defined as production and a flow from the Metering Grid Area to the Installation is defined as consumption.

To align how things are done between BRSs, the attribute "Request identifier" was removed from "Request validated measured data – additions" and the attribute Transaction ID was added to "Request validated measured data - async additions".

Actions:

- Ove will update and distribute the BRS;
- Everybody is asked to review the BRS;
- At the next meeting we will discuss if we shall merge (some of) the validated measured data for Profiled APs, continuous measured APs, Exchange Points and Installations into one document.

4 Decide the next Measure BRS to review

Discussion topics (when we come to a BRS having gas areas):

- We resolve item "6, MRs for the Harmonised Role Model" together with discussing areas for the gas sector (CVA, ARS, temperature zone etc.);
- All will verify some gas related questions:
 - Is the Aggregated Reception Station still used (and what else)?
 Answer from Sweden:
 - The Calorific Value Area is used. Aggregated Reception Station, Temperature Zone etc. are not used.
 - Are specific quality codes for gas needed in Validated Measured Data? I.e.:

Answer from Sweden:

Gas specific quality codes are not used.

5 Status for Estonian Consent seminar

Estonia intends to arrange a "Consent seminar" to discuss a common solution for all types of business sectors, among others coming from an IEEE discussion, where ebIX[®] is invited to present the ebIX[®] business requirements for administration of Customer consent. The idea was introduced by Kalle and Georg from Elering at an EG1 meeting Monday October 12th, 2020. The idea is to share ideas and learn from the North American approach. Georg is not aware of any documentation by IEEE in the Consent area. As far as Georg knows, they are not doing anything there. In North America, Green Button does have consent, but that is a NAESB standard which is behind a paywall.

It is noted that most sectors probably are most interested in who the customer is, i.e., that it is the correct customer, while ebIX[®] is more concerned about what content a party is entitled for, due to GDPR.

We have informed Kalle that ebIX[®] likes to present the BRS for administration of consent, with some considerations. Probably Gerrit will do the presentation.
