1 Approval of agenda

7 AOB

7.1 Issues arising from ebIX[®] Forum meeting March 23rd

Review of EG1 Implementation Acts:

Since it looks like the next draft Implementation Act from EG1 will be more mature, it is important for ebIX[®] to comment on it. We should organise this with members from all ebIX[®] groups (ebIX[®] Forum, EBG, ETC). Kees expects the next round of commenting before (or during) summer this year.

Action 2021a-01:

Ove will, together with EBG, invite ebIX[®] Forum, EBG and ETC (who may bring extra experts to the group) to a first planning and preparation meeting May 18th 10:00 - 11:30.

ebIX[®] and CIM EG Area project:

Leslaw from PSE informed at the latest HG meeting that CIM EG/ENTSO-E does not have enough resources to join this project now.

Decisions related to Area project:

How to organise the Area project as a new project like the distributed flexibility project phase II (with participants from other European bodies) will be put on the ebIX[®] Forum autumn agenda. Earliest start is expected Q2 2022.

Action:

- Ove will send an invitation to EBG and ETC members not being members of ebIX[®] Forum.
- To prepare an agenda for the "review of EG1 Implementation Acts" will be put on EBG agenda for May 3rd.
- A review of the project plan for an ebIX[®] Area project will be put on an EBG/RtR agenda beginning of September.

Item closed.

7.2 Review of BRS for Validated measured data

Gerrit and Kees have done a review on the BRS for validated measured data that is up for final review (for 2 weeks) and had some issues that should be corrected. The first few comments were discussed and among others the following agreed:

- We remove most of the entries in chapter "A.3 Main changes since last version" we keep one row.
- We agreed to replace Validator with Metered Data Responsible throughout the BRS.
- It was a longer discussion if the Installation should be replaced with Resource, or vice versa, but it was not reached any conclusion. However, it was started on a clarification of the content of a MP:



The discussion will be continued at the next meeting.

At the next meeting review should continue from chapter "1.2 Basic assumptions" (top of page 7).

7.3 Quantity Quality codes

We need a discussion on the Quantity Quality codes. The list in the ebIX[®] BRSs is OK, but there is a long list in the ebIX[®] code list.



Due to lack of time the item was postponed.

7.4 When to use Affected roles, Linked roles and Entitled roles?

During the latest Flex project meeting it was noted that we should make some clear rules for when to use Affected role, Linked role or Entitled role. However, due to lack of time the item was postponed.

7.5 Metered data collection method

It was noted during the latest project meeting of the Distributed Flexibility project phase II that the "Metered data collection method" is part of both the "Accounting Point characteristics" and the "Metering configuration characteristics".

Due to lack of time also this item was postponed.

7.6 Is the centre of measure data linked to Metering Point (MP) or a Customer?

Kees brought up the question, based on some discussions within EG1 – there the main view is that measure data is (primary) connected to a Customer and not a MP.

It was agreed that the Customer probably will be more important in the future as a starting point for processes, however the Customer will not replace the MP in the foreseeable future.

Conclusion:

• In the present, the MP is the centre point, but in the future the Customer may be the centre point.
