

Jan (SE) informed from the WG16 modelling team meeting March 31st:



When briefly showing the figure above Becky noticed that we have not (yet) provided the MRs for the associations between MktActivityRecord & Reason & MarketParticipant.

Another thing that I noted myself was that we will need some examples showing when a "DateAndOrTime" or a "Process" etcetera are to be associated with a MktAcitivtyRecord.

But I think I can look that up within the ebIX® documentation. To be presented at the next CIM EG Retail market group meeting.

Ove replied that there are examples in the MRs of "examples showing when a "DateAndOrTime" or a "Process" etcetera are to be associated with a MktActivityRecord", such as:

The association from MktActivityRecord to DateAndOrTime is typically used for:

- A start date and/or end date, such as for start or end of supply.
- A snapshot date, such as when the master data from a MarketEvaluationPoint was extracted from the database, telling the situation in the database at a specific date and time. The date can then be another date than when the message was exchanged.
- A Validity date, i.e. the date when an event or object was or will be valid.

We will not update the MRs already submitted now – Jan (SE) will instead show examples in a PowerPoint presentation. The topic will be continued under item 4.4.

The bullet points below were rephrased.



Actions:

- Kees will try finding the definition of source and target for associations according to UML and CCTS.
- Jan (SE) and Kees will try finding contradictions between the usage of source and target between basic CIM (301) and ESMP (351).

4.1.2 MRs based on Dutch requirements

4.1.3 Status for governance of reference models: basic IEC CIM and ESDMP (follow-up item on the agenda)

Alvaro is maintaining the latest version of the ESMP, based on decisions in CIM EG. Hence, these updates are extensions to the CIM 62325-351 standard. Currently the ESDMP is maintained by ETC.

Jan informed that Alvaro and Jan (SE) will do a QA of the latest update of ESMP on Friday April 22nd, before Alvaro will submit the updated version to Becky.

Thereafter it will be proposed have a e.g. three months trial period.

Review and update of Excel sheet keeping track of the MRs sent from ebIX®, via the CIM EG Retail Market Subgroup to WG 16. The Excel file is uploaded to the Teams "Team" "ebIX® ETC" where Jan (NL), Jan (SE), Kees and Ove can edit the document simultaneously.

Ove had as action moved the 5 first MRs and the three last (2022/011, 2022/012 and 2022/013) from the current Word document to the new Excel sheet and update it in the Excel status sheet from Jan (SE).

Jan (NL) had added the Dutch MRs to the Excel file.

Ove had also, on request from Jan (SE) (and WG16), made two draft MRs: ebIX® 2022-009 (add association MktActivityRecord – MarketParticipant) and (ebIX® 2022-011 - add association MktActivityRecord – Reason).

Appendix A ebIX® rules for how to make MRs to WG16

- 1) Artefacts used for MRs to WG16 shall be stored as separate packages in the common cloud EA model.
- 2) Always review existing definitions of attributes, classes etc. that are related to the MR in question and if needed propose updates to these definitions.
- 3) First investigate basic CIM to see if the object we intend to send an MR for already is available there.

 If yes, we should make a MR for 62325-351 (ESMP), if not we make a MR for both basic CIM and ESMP.
