1 Approval of agenda

The agenda was approved with the following additions:

2 Approval of minutes from previous meeting

The minutes from previous meeting were approved without comments.

3 Review of Change of Supplier and Move BRS

The intention with this item was to discuss the scope of "supplier centric modelling" and for instance the Eurelectric part (Make supply contract, Verify existence of grid contract etc.). Do we still need these processes in the ebIX® model?

During the discussions, Kees mentioned that EG1 (EU Commission Smart Grid Task Force / Expert Group 1) discuss if the models should be "Customer centric" instead of "Supplier centric". It was decided to ask Eurelectric if they would like to contribute in the update of the Eurelectric part of the BRSs.

The review of Change of Supplier and Move BRS were added to MDS Work plan, see Appendix A.

Action:

 Gerrit will ask Lucy to ask Eurelectric for further collaboration in modelling the downstream energy market.

4 Preparation for ebIX® Forum (project proposals, EBG proposal, MDS status etc.)

- Preben mentioned that Denmark and Estonia are running a project for modelling the process for customer consent;
- Kees propose to use, for the Customer Consent, the terms obtain and maintain (where maintain includes delete).

5.1 Review of project proposals from previous meeting

5.2 Review of and make a priority list of "EBG Maintenance work"

During this item, Kees informed that one of the items discussed in SGTF/EG1 (EU Commission Smart Grid Task Force / Expert Group 1) is how to stimulate interoperability without enforcing new standards. There are three sub-groups in EG1: emerging services, billing and change of supplier / master data. For emerging services and billing there are not many published reports, BRSs or similar that can be used for making a report, hence these sub-groups will mainly define their own requirements.

For outstanding (EBG) work see also the reviewed and updated Appendix A.

The following list of work was suggested for EBG:

- 1. Define new projects and guidance of these;
 - a. Verify the need for a new project for "Efficient data alignment, including the possibility to request historical and/or future master data";
- 2. Maintain ebIX® BRSs:
 - a. starting with Change of Supplier and Move BRS, especially the Eurelectric part.
- 3. Surveys:
 - a. Making rules for why ebIX® does surveys;
 - b. Follow up on ongoing surveys:
 - i. Survey from Germany (Suppliers change within 24 hours);
 - ii. High-level impact analyses regarding the General Data Protection Regulation (GDPR).

6 Review the result and finalise surveys

The two surveys were reviewed and updated:

- 1) Survey from Germany (Suppliers change within 24 hours);
- 2) High-level impact analyses regarding the General Data Protection Regulation (GDPR).

8 Status for approval of MR for a Party Administrator in ETC and HG

9 Status for ebIX® Forum approval of BRSs

Ove had as action from previous meeting cleaned up the BRSs:

- BRS for rearrange Metering Points between grids;
- BRS for change of BRP (bulk change of BRB);
- BRS for Alignment of Area Characteristics.

The BRSs had been sent to MDS for 14 days of commenting and Gerrit had made a set of comments that were reviewed during the meeting. The updated BRSs will be published at the ebIX® web site.

Ove had made a first draft of a BRS, which was reviewed and updated. The review and update will continue at the next meeting.


- Project proposals for approval at ebIX® Forum autumn meeting:

12 AOB

12.1 Upgrade of MagicDraw

Ove has experienced an abortion of MagicDraw (MD) that resulted in an automatic generated error message to NoMagic. The response to the error message was that the error is fixed in later versions of MD.

Further, when starting MD, Ove always gets an error message regarding data losses. The losses always concern "Business Partner diagrams", normally the three last modified diagrams. Ove has earlier sent an error report to NoMagic regarding this problem, without getting a solution on the problem. It is however not sure that an upgrade of MD will solve this problem.



Ove asked if any MDS members will get problems if we upgrade MD to latest version 18.5 SP3? A decision will be put on the next ETC meeting agenda.

Status:

- Finland is using version 18.3 and don't know if there will be any problems.
- In Germany only BDEW (Christina Frein) is using MD.
- Belgium will migrate to EA, but has a MD licence that will last until the end of this year. Belgium is currently using version 18.2, but has no problems with ebIX® upgrading.

Action:

- All that are using MagicDraw (MD) are asked to inform Ove which version they are using and if they will have a problem if we upgrade to the latest MD version, i.e. version 18.5 SP3;
- Ove will make an upgrade to test if the MD file will work with both versions (18.2 and 18.5).

12.2 Status for the EU Commission Smart Grid Task Force (SGTF)

Kees informed:

- ebIX® participates in EG1 (Expert Group 1), EG3 and in the steering committee;
- Both EG1 and EG3 has editorial groups, where the main work is done;
- In EG3 (flexibility) ebIX® has taken on the responsibility of ensuring that the Harmonised Role Model (HRM) is up to date;
- EG1 (interoperability in data exchange) is probably the most important group for ebIX®:
 - Kees is taking part in the Change of Supplier editorial group;

- o The intention is to also cover master data MP in the final report;
- Kees would like Austria, Belgium, Netherlands, Slovenia and Sweden to specify their national deviations related to the ebIX® Change of Supplier process. The result is meant as input for discussion within EG1.

• The final reports from the mentioned subjects are expected before summer this year.

Proposals for new EBG projects

B.1 ebIX® Customer Consent project

Background

- The GDPR enforces explicit Customer Consent before exchanging privacy related data from the Customer to parties that do not have access to data by other legal reasons.
- Ongoing IEC WG16 project "My Energy Data":

"make a generic description of services to offer customers (residential, municipalities, ...) the possibility of downloading their energy consumption information and granting access to third parties to that information to enable service providers to offer analytical and other services to customers (residential, municipalities, ...)".

- The project is initiated by EU Smart Grid Task Force (SGTF) / Expert Group 1 (EG1) and CENELEC.
 The result is meant to be a European standard that can be followed by all European countries.
- The scope of that project is currently distribution of metered data;
- ebIX® sees a strong need to properly model customer consent (with the consequence of how to handle third parties in a Metering Point administration).

Reason:

 With the eminent short time need for it, using the ebIX expertise on master data to fill in the gap that seems to exist in the EU working groups to properly model Customer Consent.

Goal:

Deliver on short notice a harmonised model for information exchange related to Customer
 Consent within the European energy market, obtained and maintained as master data.

• Scope:

o Information exchange related to (use of) Customer Consent within the European energy market.

Deliverable:

- o ebIX® BRS for how to obtain and maintain Customer Consent.
- **Start:** ASAP;
- End: August 2018;
- Expertise: Business people understanding processes related to access data;
- Proposed way of working:
 - 2 two-day "face-to-face" meetings;
 - Skype/GoToMeeting when possible;
 - Focus on homework.

B.2 ebIX® role-to-role project

Background

• Extend the existing ebIX® business process models (BRSs) to include information exchanges between roles that not yet are covered.

Reason:

- A growing number of ebIX® member countries uses or plans to use a datahub and is confronted with:
 - Missing information exchanges (e.g. between Grid Access Provider and Metering Point Administrator).
 - Lack of complete lifecycle of a Metering Point.
- Goal:
 - O Make sure that the ebIX® model fits markets with datahub(s).
- Scope:
 - o Add missing information exchanges between relevant roles.
 - o Model the complete lifecycle of a Metering Point.
- Deliverables:
 - New and/or updated BRSs.
- Start: Q3/2018;
- End: Q1/2020;
- **Expertise:** Knowledge of business processes and data using a hub and in-depth knowledge of the existing BRSs;
- Proposed way of working:
 - Two-day "face-to-face" meetings;
 - Skype/GoToMeeting when possible;
 - o Focus on homework.
